Declaration of Result of 1st year Diploma Courses in June every year / Appointment OMBUDSMAN in Polytechnics / Autonomy to Polytechnics / Release of FDR for AY 2010-11 the Institutes by the State DTEs / Addresses of the Govt. Institutes.

Sir.

The following issues are brought to your notice for consideration / further necessary action:

1. Declaration of Result of 1st year Diploma Courses in June every year:

As you are aware, All India Council for Technical Education grants approval for admission students into Second Year of Diploma/Degree/MCA Programs through Lateral Entry as per the Approx Process Handbook.

Polytechnics running Diploma Courses fall under the purview of the Directorate of Technic Education of the respective State Government. Therefore, you are requested to complete Resdeclaration of the Diploma Courses in june every year so that the admission process for students seeke admission into Second Year Diploma Courses under Lateral Entry Category becomes smooth w sufficient time for the students to decide and apply for the desired Course.

The above suggestion shall be implemented for the year 2019-20.

#### 2. Appointment of OMBUDSMAN in Diploma Institutes: -

It is intimated that in accordance with appendix 15 of APH 2018-19, appointment OMBUDSMAN is essential in order to provide timely redressal to Grievances expressed by students 'I appendix reads as under:

"In order to ensure transparency by Technical Institutions imparting Technical Education, in admission . with Paramount Objectives of preventing unfair practices and to provide a mechanism to students Redressal of their Grievances, AICTE has notified Regulations for establishment of mechanism for Grieva Redressal Committee and OMBUDSMAN for all the AICTE approved Technical Institutions vide No. 37 Legal/ 2012 dated 25.05.2012. In case of non-compliance of above Regulations shall call for punitive acagainst any willfully contravenes or repeatedly fails to comply with the provision of above Regulations."

In view of the above, all DTRs of State Govt, are requested to nominate an OMBUDSMAN in Polytechnics before commencement of session 2019-20. Action Taken Report may be submitted to AICTE so that records of the Council are updated.

The above suggestion shall be implemented for the year 2019-20

## 3. Autonomy to Polytechnics: -

It is intimated that Universities are giving autonomy to Degree Engineering lauriations. However, there is no such authority available for providing autonomy to Posytechnic Institutes on India. although Polytechnic institutes are established under the aegis of DTE in every State. In the self-this there are no Regulations for Autonomy to Polytechnic Institutes in India

Therefore, the Competent Authority, AICTE has decided to obtain views of State Governments / DTEs on the same so that it can be examined and suitable Regulations, if required, can be evolved.

Hence, all State Governments / DTEs are requested to provide their views on Autonomy to Polytechnics, at the earliest.

# 4. Release of FDR for AY 2010-11 to the Institutes by the State DTEs:-

It is intimated that prior to AY 2011-12, the FDRs were created by Institutes in the joint name of DTEs and Institutes. As per APH, these PDRs can be released only after the promoter applies online on the AICTE web portal. After following the procedure specified in the APH, NOCs for release the FDRs are issued by AICTE. However, instances have been noticed where some DTEs have released FDRs without NOCs from AICTE.

All DTEs are therefore, requested to release FDRs only after issue of NOCs from AICTE.

## 5. Addresses of the Govt. Institutes: -

It is also informed that the details relating to address indicating the correct site/ location in which Govt. Institutes are functioning are not complete in AICTE web portal. This is an essential requirement which needs to be complied with by all the Govt. Institutes. Further, this information will enable the Council to consider the requests of institutes functioning on temporary site and applying io: change of site to permanent location, as per AICTE norms.

All DTEs are therefore, requested to furnish the details relating to addresses indicating the correct site / location in which Govt. Institutes are functioning
